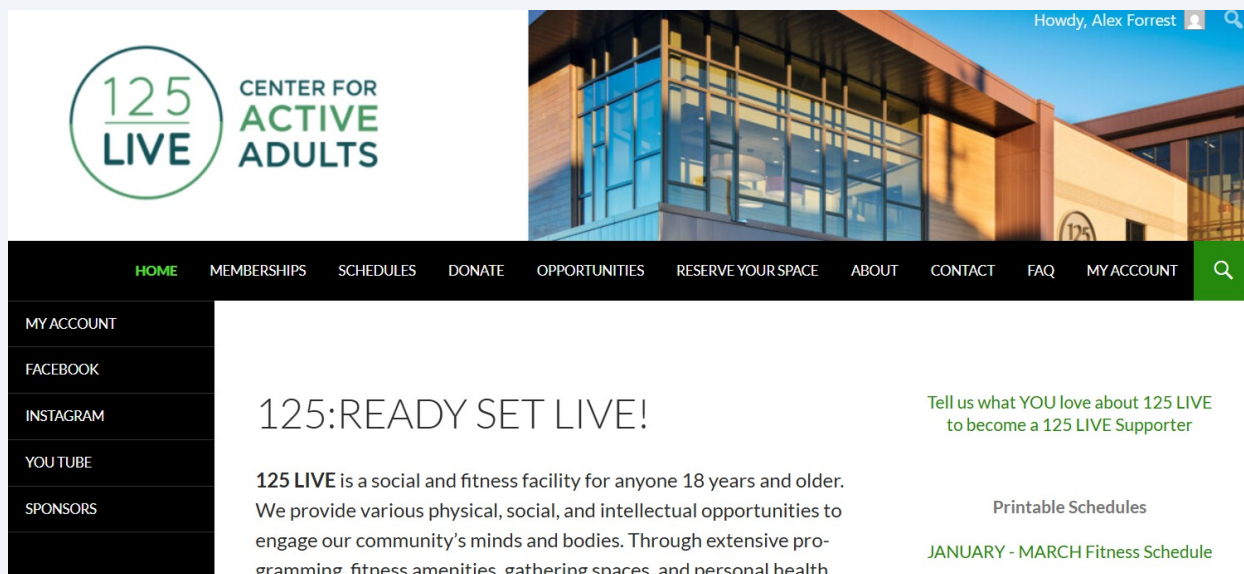



# 125 LIVE MEMBERS - How to Reserve Pickleball Court #1 Online

- Time Limits:**
  - During open play, please limit play to one hour if others are waiting for a turn.
  - After your session, please promptly vacate the court to allow the next players to begin in a timely manner.
- Court Etiquette:**
  - During peak hours, please utilize a "rotate in" system to allow others the opportunity to play.
  - Invite other members to join in for double if courts are full and only two are playing.
  - Pick up all personal belongings and dispose of trash in designated locations.
- Respectful Play:**
  - Always maintain a positive and respectful attitude toward fellow players.
  - Communicate clearly with others to avoid misunderstandings during games.
  - Be mindful of the noise level, especially if games are happening on both courts.
- Sportsmanship:**
  - Follow the general rules of pickleball and be prepared to call your own faults and lines honestly.
  - Show sportsmanship by respecting others. The goal is to have fun while connecting with others.
- Equipment:**
  - Members should bring their own paddles and balls, though some equipment is available at the front desk for checkout if needed. Those using 125 LIVE equipment will be responsible for any loss or damage.
- Weather Policy:**
  - In the event of inclement weather, court access will be subject to our standard facility weather policies.
  - If a facility closure occurs, Court #1 reservations will be canceled and must be rebooked for another time.

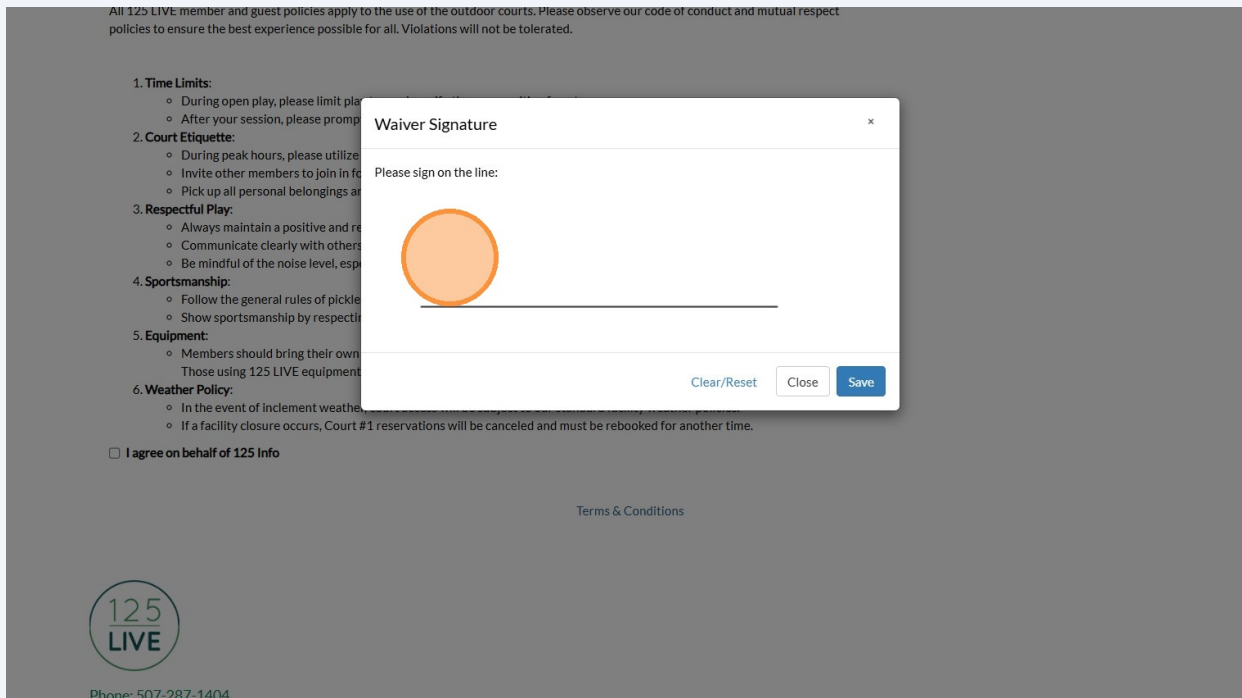

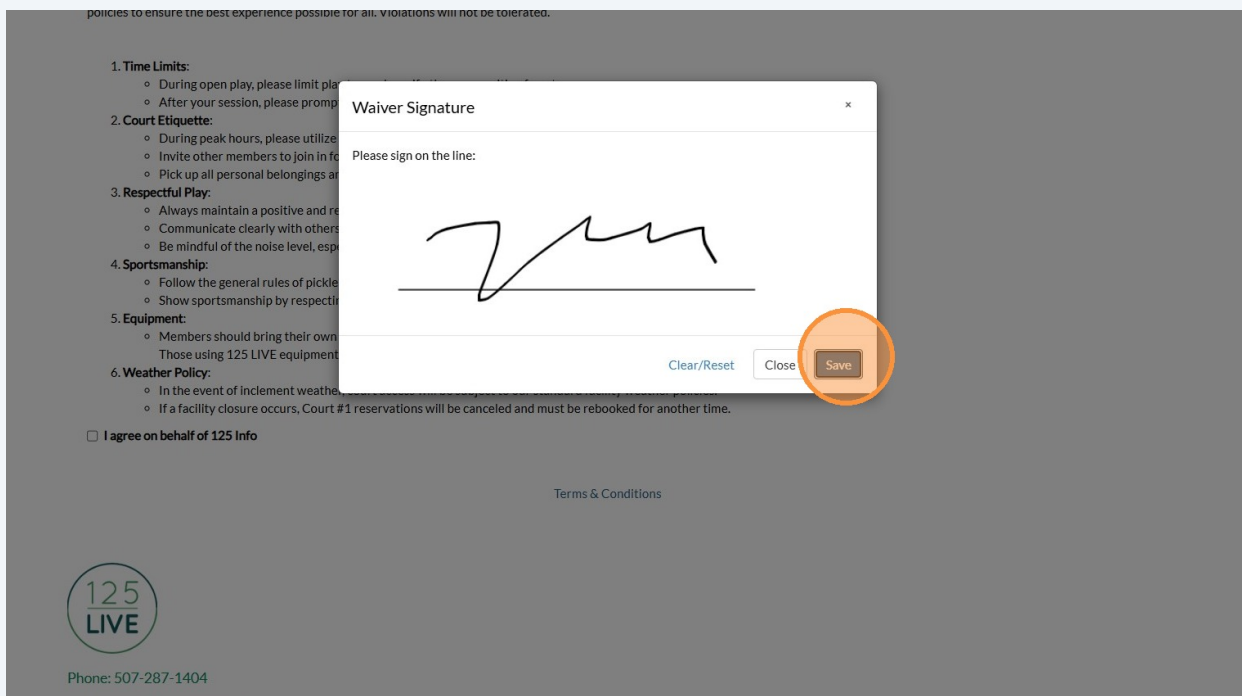
